**I. Educational Qualifications for the Post of RBI Chair Professor at Faculty of Commerce:**

- A (i) An eminent scholar with Ph.D. Qualification(s) in Banking & Insurance / Economics/ Business Finance and or concerned/allied/relevant discipline and also published work of high quality, actively engaged in research with evidence of Published Work with a Minimum of 10 Publications as Books and/or Research/Policy Papers in area of 'Banking & Insurance' and or concerned/allied/relevant discipline.
- (ii) A Minimum of 10 years of Teaching Experience in University/College, and/or Experience in Research at the University/National level Institutions/Industries, including Experience of Guiding Candidates for Research at Doctoral Level.
- (iii) Contribution to Educational Innovation, Design of New Curricula and Courses, and Technology- Mediated Teaching Learning Process.
- (iv) A Minimum Score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), set out in this Regulation in Appendix III.

OR

- B. An outstanding professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the Concerned/allied/relevant discipline, to be substantiated by credentials.

Candidate should preferably a full time Professor or at least an Associate Professor who has published works of high quality especially in area of 'Banking & Insurance' and or concerned/allied/relevant discipline, actively engaged in research and training as well as having 10 years' experience of teaching and/or research, including experience of guiding research in a leading academic institute or holding an equivalent position in a non-academic organization in the age below 62 years shall be eligible to apply. Chair Professor is expected to undertake research in the relevant field and publish papers in international/national refereed journals based on his/her research. Selected Candidate shall be also required to teach in academic programs being offered by the Faculty of Commerce. Chair Professorship is to be initially awarded for three years, subject to further extension as per RBI and University rules and subject to satisfactory performance. Candidate on deputation shall also be considered for the tenure appointment.

1. Only online applications with required uploaded enclosures will be accepted. Applicant should send one hard copy of the application on or before **08/03/2019** along with all self-attested testimonials, certificates and all supporting documents relating to Academic Performance Indicators (API) or else the application will not be considered. Applicant must produce original testimonials, certificates and other documents at the time of interview, if called.
2. The Last Date for receipt of Online Application is fixed as **05/03/2019 till 6.00 p.m.**
3. Applicant should refer UGC and AICTE guidelines for Academic Performance Indicators (API) whichever is applicable before filling the application form.
4. A candidate who knowingly or will-fully furnish incorrect or *false particulars* or suppresses material *Information*, will be disqualified and if appointed will be liable to dismissal from service, without notice.
5. *If any additional information is to be given, the information in separate sheet should be uploaded.*
6. The candidate must possess the required qualifications at the time of last date fixed for *receipt* of online applications in the notification by the University i.e. 05/03/2019.
7. *Canvassing direct or indirect will be a disqualification.*
8. *Reservation of posts are restricted to those who are proclaimed as such and in support of this, a certificate of competent authority from the Gujarat State is required to be submitted along with the application. The SC/ST candidates of the States other than Gujarat State shall be considered eligible for recruitment against the reserved posts subject to the condition that they have to produce necessary certificates from the competent authority of Gujarat State.*
9. The posts which are reserved for special category, the candidate who does not *fall under* the said respective *category should not apply.*
10. If the number of candidates possessing minimum qualifications is *large*, the University reserves the *right* to short-list the candidates on the merit based criteria for the purpose of calling for interview.
11. **For the post of Professor API Score page is compulsory field to be filled up or else his/her application will not be considered.**
12. For the post of Professor *Candidate* has to make presentation before the Interview in *front of Selection Committee*, where *staff of the Department concerned and all candidates* who are called for Interview will be allowed to remain present. The presentation *will* be for a maximum of **15** minutes on the *topic of candidate's choice* in the subject concerned.

13. Candidates, if called for interview, will have to come at their own expense.
14. The University reserves the right to fill in or not to fill in any post or to alter the number of posts in any cadre or in any / all the subject or make any amendments.
15. Selected candidates may be posted in any Institution of the University.
